

BERMUDA DREAM TRIP FOR 2 - RAFFLE

1. Entries are open to all adults 18 years and older. No one under 18 may receive a prize.
2. No more than 500 entries will be sold. The odds of winning are 1 in 500.
3. The price of each raffle entry is \$20 U.S. or 3 entries for \$50
4. There is no limit to the number of entries an individual may purchase.
5. An entry purchaser does not have to be present at the drawing to be eligible to win a prize.
6. Entry purchases may be made in cash or by certified funds, personal check, or by PayPal. Call 802 223 0804 for instructions for paying with PayPal.
7. All entries must be paid for at the time of purchase. Entries made via e-mail or telephone will only become official when funds are received by MRNA. Those funds must be received before the time specified in rule 9 (below) for the entry to be included in the drawing.
8. The winner will be notified by certified mail, and the winner's name will be announced on the MRNA website, www.MRNAvt.org.
9. No raffle entries will be sold after August 20, 2009, 7:30 pm eastern time. Requests for entries received after that time, or after 500 entries have been sold, will not be included in the drawing and will be returned. Entry requests will be subject to acceptance by MRNA.
10. For the name of the winner, send a self-addressed, stamped envelope to MRNA 3549 Route 100 B, Moretown, VT 05660, after August 20, 2009.
11. If fewer than 250 raffle entries are sold by 12 noon eastern time, August 20, 2009, MRNA reserves the right in its absolute discretion to convert the raffle to a 50/50 cash prize raffle.
12. The prize being offered is a 1 week, all inclusive cruise FOR TWO from Boston, MA to Beautiful Bermuda!!! It is on the Norwegian "Spirit" and is an outside balcony room. The prize also includes a night's stay in Boston and parking while on the cruise. Everything on the cruise is included including meals. (no alcoholic beverages). MRNA will notify any entry requests received after August 20, 2009 at 7:30 pm eastern, or when 500 entries have been sold, that the raffle is closed. Notification will be done by e-mail.

The winner will be selected at a random drawing from all eligible entries to be conducted at the MRNA fundraiser at American Flatbread in Waitsfield, VT on August 20, 2009 at 8 o'clock p.m. by an independent party whose decision shall be final and binding in all respects. The winning entry will be drawn from a container in which all eligible entry stubs purchased for the drawing will be mixed. Each entry stub will have an equal chance of being drawn.
